Terms and Conditions of Auction

1. Inspection of Vehicles

The vehicles shall be available for inspection at the Explosives Management Division (EMD) Head Office, Phuentsholing, during office hours from 9:30 AM to 4:00 PM until December 2, 2025.

Interested bidders are advised to inspect the vehicles thoroughly prior to bidding. No complaints, claims, or requests for withdrawal of bids shall be entertained after the auction.

2. Submission of Sealed Bids

(a) Bidders shall submit their bids in a sealed envelope, clearly marked "*Bid for Auctioned Vehicles*", addressed to the Senior Superintendent of Police, EMD, Phuentsholing.

(b) Each bid must be accompanied by a bank draft of Nu. 25,000/- (Ngultrum Twenty-Five Thousand only) drawn in favor of the Senior Superintendent of Police, EMD, Phuentsholing, as a security deposit.

(c) All bids must be submitted on or before December 3, 2025 (before 4:00 PM). Late submissions shall be summarily rejected.

3. Opening of Sealed Bids

The sealed bids shall be opened by the Auction Committee on December 4, 2025, at 10:00 AM in the office of the Senior Superintendent of Police, EMD, Phuentsholing.

Bidders or their authorized representatives are encouraged to be present. The highest valid bidder for each vehicle shall be declared on the same day, subject to Committee approval.

4. Retention and Refund of Security Deposit

(a) The security deposits of the first and second highest bidders shall be retained until completion of the auction process.

(b) The deposit of the successful bidder shall be adjusted against the final auction value.

(c) Deposits of all other unsuccessful bidders shall be refunded without interest after the completion of the auction.

5. Default by the Highest Bidder

Should the highest bidder fail to deposit the full auction amount within the prescribed period or refuse to take delivery, the security deposit shall be forfeited, and the offer may be extended to the second highest bidder at the discretion of the Committee.

6. Payment and Delivery of Vehicle

The successful bidder shall deposit the entire auction value into the EMD CD Account within seven (7) days from the date of confirmation of award.

Upon confirmation of payment, the vehicle shall be handed over to the purchaser in its present condition, on an “as-is, where-is” basis. No claims relating to condition or quality will be accepted thereafter.

7. Transfer of Ownership

The winning bidder shall complete all formalities related to ownership transfer within ten (10) days from the date of issue of the ownership certificate, including payment of all applicable taxes, transfer fees, and other statutory charges.

8. Vehicle Registration Plates

The existing registration number plates shall be removed before delivery of the vehicle. The winning bidder shall obtain new registration plates at their own cost.

9. Right of Rejection

The Auction Committee reserves the right to reject any bid that is incomplete, overwritten, ambiguous, or does not conform to the prescribed terms and conditions, without assigning any reason.

10. Final Authority

In the event of any dispute, interpretation issue, or unforeseen situation, the decision of the Auction Committee shall be final, conclusive, and binding on all participants.
